Unwavering Support for Quebec Foster Families

In the last issue of the Inform'Accueil, we told you about the upcoming raid. This took place in January 2023, with the result that we retained the regions we represent, which means 50% of Quebec's regions. Thank you to all our members, employees and friends who worked so hard to communicate their assurance that FFARIQ is the association best equipped to represent foster families, since it is itself made up of foster families.

Now it's time to negotiate!

REVIEW OF THE EXTRAORDINARY GENERAL MEETING (EGM)

On May 10, we held an EGM to inform our members on various issues and to gather their opinions to guide our further actions. Three important topics were discussed.

Negotiation and priorities

We have presented our members with a negotiating brief. It was drawn up on the basis of the concerns you expressed to us during the plenary session held at our October 2022 convention, as well as the communications received for consultation, support and guidance on various subjects and delicate situations. The various disagreements tabled are also part of the elements we have integrated into these specifications.

It is therefore with your approval that we enter into negotiations with the Ministry. We will keep you rigorously informed of the progress of negotiations, so that we are always in a position to represent you properly.

Exceptional lump sum

We informed you that the Auxiliaire aux services de santé et services sociaux (ASSS) had won its case. Instead of the large gain that should have been offered to resources as provided for in the ARR and the collective agreement, the Ministry called the five unions together to inform them of a much lower offer. Following the information we sent you concerning the Ministry's decision, its impact on your reality, and the decision of certain unions to accept this discounted offer, you mandated us to continue the discussion. We will continue to defend your interests on this point and keep you informed of developments. 3 Bill 15

With this bill, the Ministry wants to reduce the diversity of unions by region. It also wants to standardize processes and applications across all regions to avoid dissonance. We're keeping a close eye on the situation and will keep you informed.

FFARIQ IS QUEBEC'S LARGEST CHILDREN'S RIGHTS ASSOCIATION

In this context, the Board of Directors has decided to continue to respond to all Quebec foster families who have become members, in addition to allowing them to benefit from the free training and conferences we offer our members. They also have access to child development tools, advice, and various discounts. However, certain services are reserved exclusively for member families in the regions represented by the FFARIQ, such as support and advocacy with institutions, participation in regional and provincial activities, and free telemedicine services.

HAVE YOU COMPLETED YOUR TELEMEDICINE REGISTRATION?

In the last Inform'Accueil, we informed you that FFARIQ had decided to offer telemedicine services free of charge to the members it represents. Many of you expressed your enthusiasm. To date, 343 members represented by the FFARIQ have used this telemedicine service. This service, offered exclusively to our members in the regions we represent, is a response to the difficulties you face when you need to see a doctor quickly for yourself or your children. It seemed only natural to set up this service to support you in your day-to-day work.

If you still haven't registered, go to YourSpace to download the application.

Message from your Negotiating Committee

The negotiating committee of the Fédération des familles d'accueil et des ressources intermédiaires du Québec (FFARIQ) has presented its work for the upcoming negotiations. The committee, made up of Geneviève Rioux, FFARIQ provincial president, Chantal St-Pierre, coordinator of negotiations and application of the collective agreement, and Éric Martineau, lawyer, believes that it is essential to inform and consult FFARIQ members

and officers, so that they all support this negotiation project. For the committee, we must all address our demands to the Ministry of Health and Social Services together.

So, on May 6, 2023, the committee first addressed the members of the Board of Directors gathered in the new Trois-Rivières offices. **Two extraordinary general meetings were held by videoconference on May 10, reaching a large number of foster families.** Finally, on May 17, a final presentation was made, in English, at an extraordinary meeting for our Englishspeaking resources.

The committee hopes to have demonstrated the rigorous process that was used to establish, first and foremost, the major issues at stake in these negotiations. Once the backdrop had been established, the committee set about identifying the priority demands that would be presented to the MSSS and that truly corresponded to our members' reality.

Over the past two years, the committee has paid close attention to the application of the agreement and the interpretation issues that have arisen. The committee has asked itself a number of questions: What adjustments need to be made to ensure that the collective agreement is applied more consistently? What difficulties are regularly encountered? What are the recurring issues raised with the institutions? And finally, what issues have been the subject of disagreement? This helped determine priorities for negotiations.

HERE IS A BRIEF SUMMARY OF THE ISSUES AT STAKE AND SOME PRIORITY REQUESTS :

1 Ensure compliance with specific agreements

• Major overhaul of the specific agreement, in terms of duration, number of regular places, respect for resource competencies, rights of regular and local foster families, etc.

2 Ensure a common understanding of the concepts used in the agreement

• Improved notions of recognized place, occupied place, permanent departure, temporary absence of the child for regular foster families and proximity families, etc.

3 Ensure the correct and respectful use of administrative and clinical-administrative processes

• Access to more precise reasons during administrative meetings, non-abusive use of blame, more general access to support during investigations or administrative meetings, recourse when terminating agreements, etc.

4 Ensuring optimal and safe service conditions

• Improving the time it takes to move a child, improving support measures, identifying transportation that puts the resource at risk, consulting the resource during the development and revision of the intervention plan.

5 Adjust remuneration and improve payment and reimbursement procedures

- Increase in reasonable expenses, reimbursement of transportation per trip instead of per day, time limit for reimbursement of expenses incurred by the resource, addition of reasons for transportation entitling to reimbursement of expenses incurred.
- Review of various salary aspects

Following these meetings, the negotiating committee sent the notice to negotiate to the Minister. As a result, the negotiation phase has begun. We will keep you informed of developments in this priority issue for the FFARIQ.

LIFE Story!

Jean-Pierre and Patrick, foster family since 2009 Mixed Bank | Laurentides

Jean-Pierre and Patrick wanted to have children. After considering various options, they decided to become a mixed bank foster family. They are currently fostering two children, including 6-year-old Tristan.

A leap in the dark

Tristan was already carrying a lot of baggage when Jean-Pierre and Patrick met him. Domestic violence had run in his biological family. Tristan had been injured himself. At the age of six months, he was placed in foster care for the first time, then returned to his biological family. Tristan lived through another placement with a return to his biological family. Tristan's grandmother offered to take him in. However, out of kindness and to ensure stability for the little one, she asked that he be taken in by another family. This is how Tristan came to be with Jean-Pierre and Patrick, his 4th foster family. It was November 2019. He was then 2 and a half years old.

We are told that the children arrive in a bad state.

When Jean-Pierre recounts Tristan's arrival in his family, he says he took a leap of faith. "We're told that the children are sometimes in a bad state. We don't understand what that means exactly," confides Jean-Pierre. An initial one-hour meeting between Tristan, Jean-Pierre and Patrick and

the proximity foster family, Tristan's grandmother, took place at the youth center, in the company of the social worker. "It was very intimidating. You had to establish contact, make a connection. I was sitting on the floor and it was cold," recalls Jean-Pierre. Fortunately, Patrick and Tristan made a great connection.

A second meeting took place at the couple's home. Tristan spends three hours there. The next day, November 4, 2019, Tristan officially arrives home with only the clothes on his back and a coat. On November 5, Jean-Pierre drives Tristan back to his daycare center, then goes shopping with a drawing of the boy's foot on a piece of paper in his pocket, to make sure he buys shoes and boots in his size, as well as clothes. When Tristan returned from daycare with Patrick, he asked, "Is all this mine?"

TAMING EVERYDAY LIFE

Everyday life slowly settles in, revealing Tristan's needs and shortcomings. The little fellow is fearful and has difficulty making connections. You have to set limits and explain why. Taking a bath every day, sitting down to eat, not throwing food on the floor, being toilet-trained: these are all part of the necessary learning process. "We wanted to give him a solid foundation, because we knew that during the first year, there are evaluations after 30 days, 6 months and 1 year, and that the judge could have decided to return him to his biological family," Jean-Pierre explains. During the first week

of the placement, an anonymous report was made. Tristan had injured himself playing at home. The couple took him to the emergency room. "We met with the youth center. We were interviewed individually. Then Tristan stayed with us," adds Jean-Pierre.

LIMITS AND SAFETY THAT PUT THE SMILE BACK ON YOUR FACE

The first two years of troubled life for this helpless little fellow have left their mark. He has developed separation anxiety, which the social worker also calls an attachment disorder, and teachers at school call attention deficit disorder (ADD).

Tristan had difficulty with rules and opposition. Jean-Pierre plays the role of authority, while Patrick fills another educational gap. "We had to set limits, because he didn't know where to stop. I told him that on the third intervention, I'd ask him to sit down. And I had to respect that rule. At first, he would disconnect from his body without being aware of it, as if he were in a trance."

The couple also had to figure out how to create a secure bond with little Tristan. When he arrived, he had no pacifiers or blankets to comfort him. Bedtime was difficult. It sometimes took up to an hour and a half to get him to sleep. "We finally realized that his mother locked him up in his room. We had to make him feel safe, tell him again that we'd be there the next day, that we'd be having breakfast and that if we ran out of cereal, we'd go and buy some more."

Things are going well at the daycare. Jean-Pierre communicates well with the educators, which helps maintain the same rules as at home and ensures a consistency that greatly helps Tristan. After 6



months, the educators noticed that the young boy was laughing. This is something new. They have also noticed that he can now settle down and is calmer.

STARTING SCHOOL

Starting kindergarten meant a period of adjustment. This brand-new environment led to some more difficult episodes, but today things are going well. "Tristan understands better because he's growing up. He's made friends. He's learning well, he's very curious about everything. He's starting to read. He's very bright and intelligent, and he's gaining self-confidence," says Jean-Pierre.

But there are still some challenges. Tristan has Peter Pan syndrome. He doesn't want to grow up, because he thinks his mommy will come back for him. Despite the repercussions and loss of bearings caused by the succession of temporary placements and returns to his biological family, his adaptation to school is going well. He is learning to forge new bonds with the educator and teacher, and to find a new balance. The stability he experiences at home must also be established at school. "There are challenges to his values. He's afraid of losing his security. We have to reassure him, remind him that no matter what happens, we'll be there. He's learning more and more to name his needs, such as seeing his aunt, a very significant person for Tristan, whose maternal side is a plus for him," Jean-Pierre recounts.

THE IMPORTANCE OF THE EXTENDED FAMILY

"When you decide to become a foster family, it's the whole extended family that will give the child a place. They are the pillars because it's not always easy. You have to know that you're not alone, that your family and friends will always be there," confides Jean-Pierre.

The couple can count on precious close friends and family. A friend of Jean-Pierre's, who is like his sister, is very present in their lives. Patrick's two sisters and his parents, affectionately known as Grandma and Grandpa, are very much there for them.



Sadly, Grandpa passed away two years ago. "Tristan often asked to visit Grandma and Grandpa. He had a great relationship. Even today, he often asks where Grandpa is."

"MY MOST BEAUTIFUL CHAOTIC EXPERIENCE"

Becoming a foster family changes daily life in a major way and brings with it a whole new set of emotions. "I had to take a year's parental leave. My bosses are very accommodating. It's been the most chaotic experience of my life. When you throw yourself into a void, you don't know that you'll have so much support. The FFARIQ is there. So is the youth center. The visions are different, but we want to grow our flowerbed. We learn as our vision changes. The vision is that a child is entrusted to us, and we take him as far as possible. All in all, what we want is the best for Tristan," says Jean-Pierre.

Since 2019, a number of children have entered Jean-Pierre and Patrick's lives. It's not always easy to live through these arrivals, but especially these departures. "We had our first child when he was born, and we went to the hospital to pick him up. His mother was a drug addict. He stayed 30 days. His mother went into rehab and we lost the child. My heart closed up after that. I was so sad to see him leave our nest forever. I went through a major mourning process. I asked for support to help me live through this separation and better understand our role," confides Jean-Pierre.

THE STRENGTH OF A NETWORK

The first year with a first child is quite an adventure! You have to get to know the world of caregivers and adapt each time things change, which is a difficult aspect, because you have to stay connected, maintain communication and establish everyone's role. You have to maintain consistency, stability, and balance for the child, while at the same time getting to grips with visits from caregivers and recognizing the rights of foster families. "FFARIQ and other foster families are there to help us. Social workers aren't always aware of this. They make us do things we shouldn't have to do. The FFARIQ helps us assert our rights," says Jean-Pierre.

Having become foster families shortly before the pandemic, Jean-Pierre and Patrick sought to break this imposed isolation by finding out where they could make contact with other foster families. "The meetings helped us. By talking to people who are also foster families, we can vent. It's liberating and rejuvenating."

In addition to his full-time job, Jean-Pierre is director of the Laurentides regional committee, where he uses his experience to help new foster families get to learn their new role.

And what about little Tristan? "We'll be in Tristan's life forever."

TIPS FROM

How to better deal with a child being moved?

Today, I'd like to talk to you about a subject we're often asked about at the Federation: when a child leaves.

As foster families, we are fortunate to welcome children of all ages, who have experienced different situations that bring different challenges and needs. Despite our experience, our willingness, and our benevolence, we are sometimes faced with the possibility of requesting a move. The reasons are varied: **a change in personal circumstances, illness, challenges that are too great, or a risk to the safety of other family members** are just a few examples that may arise.

The foster families who contact us about this are often tired and exhausted and feel a great sense of failure and guilt. It's normal to question yourself, to wonder what you've done wrong, and what impact this will have on the child you're putting through another trauma, another separation, another departure.

CREATING THE BEST POSSIBLE CONDITIONS FOR REFLEC-TION

We're all human beings with our own limitations, and it's important to recognize and accept them. Here's what I suggest you do when you find yourself in a situation where you're considering requesting a move.

First of all, it's important to stop and think for a moment as soon as the thought enters your head. The longer you put





it off, the more urgent the need will become, and it's best to take this kind of decision calmly.

ASK YOURSELF THE FOLLOWING QUESTIONS :

Are the child's challenges and needs too great? Why or why not? How has the situation changed? The point here is not to find someone to blame, but rather the source of this feeling of helplessness. It could be illness, personal preoccupations, the child's family situation, a new baby that's demanding a lot of attention, and so on.

Can this situation be corrected, improved, and worked on to avoid moving a child? If so, what can be done?

At this stage, it's important not only to tell your social worker what you're thinking, but also to ask for support and



help. The means you have found must be part of the discussion. And yes, it's up to the institution to support you and help you find ways to stabilize the situation.

THE AIM: TO AVOID THE NEED FOR EMERGENCY MOVE

I'm not promoting move requests in this text - on the contrary. I believe that if we listen to our thoughts, look for solutions to remedy the situation, ask for support and help, and put resources in place, there will be fewer move requests.

Resources often call us to make emergency requests. They've reached a point of no return, a state of exhaustion that calls for support which, unfortunately, is difficult for our institutions to provide. If we listen to our thoughts, clearly express where we are and ask for support, we may be able to avoid the need to move a child.

SOMETIMES A MOVE IS UNAVOIDABLE

In this text, I also want to tell you that it is sometimes necessary for us, for other family members and even for the child.

You need to be aware of your own needs and limits. Don't forget that you're the conductor of the train, you're the significant other for your children, you're responsible for them all. They have great needs, but above all they need you. By downplaying your needs and pushing your limits, you create an imbalance in your environment.

We have to recognize that sometimes we're not the right environment to meet a child's needs. That we're not equipped to help them. That we are limited to protecting them or other children. In these circumstances, relocation is the only solution.

Will there be any impact on the child? **The answer is yes**. Will you feel a sense of failure and guilt? The answer is probably yes. Will you feel unsupported and even judged by the institution? Again, the answer is, unfortunately, yes. Despite all these statements, I can only advise you to listen to yourself. It's your responsibility to make the best choices for the children in your care, for your family and for yourself.

In short, face up to your thoughts, talk to the people around you, discuss with the caregiver, exchange ideas between foster families. Be proactive: don't wait, look for ways and tools to change the situation. Above all, don't put off thinking about it. If you ask before exhaustion sets in, the move will be smooth, planned, and respectful of everyone's needs.

Who does what? Do you know the respective roles of resources, institutions and of the ffariq?

Of course, being a foster family means offering a lot of love to these children, who need a secure environment where they can feel good and develop. Being a foster family also means signing a contract with an institution.

Being a foster family also means being able to count on an association like the EE

Being a foster family also means being able to count on an association like the FFARIQ.

What are everyone's responsibilities in ensuring children's wellbeing? What limits must be respected? Beyond the emotional relationship you develop with the children you care for, you also have to respect a legal contract with the institution, a bit like marriage!

We've designed exclusive online training courses to demystify all this. In an interactive mode, these training sessions are dy-

namic and clear. To access them, make sure you're a registered FFARIQ member, then log on to the YourSpace portal.

Take a little time, at a time that suits you, to be well informed so you can create the best possible conditions for the well-being of the children you welcome into your family.

Roles and responsibilities of the resource LEGAL ASPECTS

- Are there different roles or responsibilities depending on the model of foster family (family-type resource proximity family mixed bank)?
- Can the facility dictate how the foster family achieves its clinical goals?
- What does ARHSSS, ARR and YPA mean?

Geneviève Rioux, provincial president of FFARIQ and a foster parent, and Éric Martineau, union representative, answer all these questions and more, in an interactive format where you'll be invited to test your knowledge and watch explanatory videos.

FFARIQ's roles and responsibilities LEGAL ASPECTS

- How is FFARIQ different from other unions?
- What kind of situation can FFARIQ help its members with?

FFARIQ is an association created by and for Quebec foster families. Guided by the values of trust, respect, helpfulness, and leadership, it represents and looks after the interests of 2,600 Quebec foster families. In this interactive and dynamic training session, Geneviève Rioux, FFARIQ's provincial president and a foster family, and Éric Martineau, union representative, explain what FFARIQ does and can do.

Plant roles and responsibilities LEGAL ASPECTS

- Is the institution the employer of the foster families?
- Can a representative of an institution drop in on a foster family without giving notice of their visit?
- Can a specific agreement signed by mutual consent between the resource and the facility be modified?

The law stipulates that the institution and the foster family must be in a collaborative relationship, making it clear that orientations and means must contribute to the child's well-being. The law also defines the framework within which the institution must carry out its work.

Through interactive questions and videos, Geneviève Rioux, provincial president of the FFARIQ and a foster family, and Éric Martineau, union representative, clarify the legal aspects that bind you to the institution.



We're already into the sweet months of summer and the vacations for our little ones. The past few months have been busy, with the January raiding season being one of the highlights. I'd like to take this opportunity to thank you all for your continued confidence in FFARIQ.

Regional tour


