Five decades of supporting families who open their doors and their hearts to children in difficulty. 50 years that the FFARIQ, a movement made up of foster families, has put children at the heart of its priorities.

In the coming year, we will be marking this important milestone. Already, you will notice that we've refreshed our Inform'Accueil. We have also added a new section in response to your request in the 2022 survey. You wanted to know more about the reality of foster families, research projects, surveys, and polls. You'll find all this and more in the Did you know? section.

Your role has become increasingly necessary for the good of our society. The DYP's June 2023 annual report showed an 8.39% increase in the number of reports, for a total of 125,839 reports processed in Quebec.

It's thanks to foster families like you that many DYP children are able to rebuild their self-confidence and self-esteem. It's the place you give them in your caring, stable, and secure homes that helps them get back on their feet.

The FFARIQ has been working every day for 50 years to help you pursue your mission with children in the best possible conditions. And we intend to do so for a long time to come!

Changes to the FFARIQ Board of Directors

This year is also an important one, as for personal and family reasons, Geneviève Rioux has resigned as President of the FFARIQ to take on other challenges. We would like to thank her for all her hard work and dedication over the past 8 years in defending and supporting Quebec's foster families.

As a result, the Executive Board had to be reshuffled. As provincial vice-president, I was appointed interim president. Having been a foster family for 20 years, Regional President for the Côte-Nord and Interim Regional President for Gaspésie/Les Îles, I'm committed to ensuring that the crucial role of foster families is recognized. The presidents of the 8 regions and I will be there for you, working together on this important mission.

Interim Vice-President Annie Blouin, Laval Regional President. Patricia Anctil was replaced as Treasurer, having resigned, by Carolle Desjardins, Outaouais Regional President. We would like to thank Patricia for her great commitment to the FFARIQ and all her work as provincial treasurer. She will continue to act as Secretary for the Quebec region.

Extraordinary Lump Sum

On March 15 and 16, foster families voted 91,8% in favor of the proposal presented to the Ministry. We'll be keeping a close eye on what happens next, and letting you know when the money is paid out. Stay tuned for your personal newsletters.

Decoded LawsAnd Regulations



The FFARIQ is taking advantage of its appearance before a parliamentary commission to address a number of negotiating issues.

On February 7, the Commission de la santé et des services sociaux invited the FFARIQ to present its observations during the parliamentary review of the Act respecting the Commissioner for Children's Welfare and Rights.


The FFARIQ explains the importance of a better understanding of your role by the Quebec population. The FFARIQ sheds light on its vision of the role of the commissioner, notably through the transfer of the CDPDJ's powers in the area of youth protection and the creation of a Charter of Children's Rights, but also on the commissioner's contribution to your daily life.

Using concrete examples, the FFARIQ explains how the commissioner's mission must complement its own. The new commissioner must add his or her voice to yours to denounce unacceptable situations, such as the disparity that exists in the treatment of proximity foster family applicants (PFF) and accredited foster families, as well as the children they foster. For example, the commissioner should be a springboard for improving the difficulties you encounter with certain financial allowances (reasonable operating expenses, personal expenses allowance, clothing budget, transportation, etc.) and which impact the children.

The FFARIQ illustrates to elected officials the importance of training workers to better understand the role of foster families and provide them with better support. This lack of support is at the root of your requests to review the process for **moving** children with significant difficulties and highlights the need to improve your **safety through the** collective agreement.

The negotiation of your collective agreement enables the FFARIQ to address these issues, but the granting of full powers to the Commissioner is necessary, so that the problems you raise also converge with our decision-makers on behalf of the children in our care.

Foster family: a Noble Profession

"We can offer them a stable environment that might make them forget the bad start they had in life."

Hafssa Elmirou comes from a large family. She has 8 brothers and sisters. In 2008, she and her husband Hicham Afendi moved from Morocco to Quebec. Accustomed to large families, it was no surprise that Hafssa created her own job here, opening her home daycare service in 2010.

Among the children who attended her daycare center, Hafssa took in some who were being followed by the DYP. She was particularly moved by the story of a grandmother who had become a proximity foster family for her grandson, and who was no longer able to care for the child. This led to the couple's decision to make a place in the heart of their family for other children.

🚺 I help children in need," confides Hafssa. We reassure them. We give them confidence. We create a cocoon where they feel safe. We know that what they've been through isn't easy, and that it's going to mark them for the rest of their lives, so we help them to experience joy with us. We make them feel part of the family.'

Nora's arrival

On December 22, 2021, a 2-year-old boy arrived at the family's home. The next day, the DYP asked Hafssa if she could take in another child, even though the agreement stipulated that the family could only offer one place. So close to Christmas, and with all Hafssa's love for children, it was impossible for her to refuse. That's how 2-year-old Nora came into their lives. With her came a bag of clothes, a pacifier, and a cuddly toy. The little girl was calm. Hafssa remembers giving her a snack, then going to her day-care center in the basement to give her a few toys. A small bond began to form between them.

The first few days went relatively well. Little Nora was very tired and slept a lot, sleeping nearly 15 hours a night plus an afternoon nap. To avoid destabilizing her, she continued to attend her nearby day-care center. "The vacation season went well. We tried to give the children a warm Christmas and gave them presents," recalls Hafssa.

Reassuring little Nora

Then the family discovered Nora's temper. When she's upset, she throws tantrums. She has an oppositional disorder which, if she's in a bad mood, causes her to lash out and say "no". Bedtime has become a problem. So has getting dressed, especially when what she's asked to wear isn't to her taste. At daycare, Nora sometimes refuses to follow instructions. She doesn't like to be upset.

When Nora's environment becomes insecure, she is more prone to seizures. The context in which the biological parents' visits take place creates anxiety-provoking situations. To avoid some of the insecurity experienced during visits, the foster family provides transportation, since the transporters provided by the youth center often change. Sometimes, it's not the same person coming and going. This feels very insecure for the child.

From January 2022, Nora was able to see her biological parents for one hour a week, together even though they were separated, on a supervised visit. "At first, she would have fits when she left her biological parents, but then that faded. Now she calls us Mom and Dad and her biological mother Mom too," says Hafssa. Six months later, Nora saw her sister again at a party at her grandmother's house.

Her dad had to stay in a detox center for a while, as well as workshops and training in anger management and violence. He had supervised visits with Nora, then scheduled calls once a week. However, his attendance was poor and he often failed to report back, which was very distressing for little Nora. He tried to contact Hafssa, despite the fact that contact between biological parents and the foster family is not permitted.





As for visits with her mother, these were made at her grandmother's, who could then supervise the visit. Mom makes a lot of effort. She has 3 children, all of whom are in foster care. The schedule of supervised and unsupervised visits makes it difficult for her to hold down a job. Nora used to see her biological mother 1.5 hours a week. However, the mother's failure to comply with certain conditions led to a return to supervised visits.

This instability led the judge to order, on November 1er 2023, a placement until majority of little Nora with the Elmirou-Afendi family. Much to the couple's delight. Nora is much better now. She's smiling, and some of the educators thank Hafssa for taking her in. When the family's eldest biological child picks her up at the day-care center, Nora is proud to say that she's her big sister.

A noble profession that involves the whole family

"Even though you get paid to be a foster family, it's a noble profession for me. It reminds me of my daughters when they were little. When we became a foster family, my daughters were already young adults. They were often in their rooms, their noses on their phones or tablets. Now they have little brothers and sisters. They help us a lot. My oldest has moved to a condo, but she comes to the house every day. She helps us with baths and meals," says Hafssa.

Hicham left his job as an agent at Emploi-Québec to look after the children. They now have 4 in foster family. "It's definitely a lot of time, especially for the 0-5 age group. One of us has to be with them, but young children are like putty. We can offer them a stable environment that may help them forget the bad start they've had in life. If they experience love with us, they'll develop self-esteem and more confidence," emphasizes Hafssa.

For this owner of a family day care, becoming a foster family is a natural step. "When the daycare kids leave at 5, it makes me cry. I get really attached to them. The children we take in

as foster families are the same, but we're lucky enough to have them with us 24 hours a day," she confides. If she had a bigger house, she'd take in a lot more than just four!

The importance of tools

As owner of a family daycare service, Hafssa has taken several training courses, including a certificate in early childhood and another in intervention with children living with autism spectrum disorders (ASD) and intellectual disabilities. She continues to take refresher courses for her daycare center, and also follows training courses with the FFARIQ.

Deeply committed to the well-being of children, Hafssa wanted to equip herself to welcome children with special needs. Last December, she welcomed a child with mild ASD into her daycare center. "There are a lot of things I learn in my role as a home educator, thanks to the advice and intervention plans of the occupational therapists and specialized educators who come to my daycare center, which I can transpose to my children. I try to support the children as best I can, while ensuring their overall development," she concludes.

It takes patience and generosity to be a foster family, but if you love children, don't hesitate. It will change your life!"

Tips from the Pros

The transition to adulthood and its challenges

As your children grow up and approach adulthood, you're probably wondering how you can best support them. Here are a few tips for you!

The transition to adulthood can seem daunting for children in foster care, but there are practical tips to help them navigate this period of their lives.

Education and career planning

Education is a key element in easing the transition to adulthood for young people. Here are a few tips to help them continue their studies and plan their careers:

- Define educational goals to motivate them to continue their studies and focus on their future.
- Explore career options learn about available training and opportunities to make informed decisions about their professional future.

Financial knowledge and independence

Managing finances is an essential skill for easing the transition to adulthood.

- Establish a budget and manage their money to avoid financial difficulties and plan their future.
- Access specific financial assistance programs that can help them meet their needs and financial goals.

Building a support network

Having a strong support network is essential to ease the transition to adulthood.

- Seek healthy, positive relationships that allow them to feel supported and connected to others.
- Participate in community activities such as hobby groups, sports clubs, or volunteer organizations to meet new people and connect with their community.



Access to health care and mental health services

Here are a few tips to help them access these services:

- Providing information on health and mental health care resources can help them find the help they need.
- Accompaniment in the healthcare system, including helping them book appointments, understand medical procedures and feel supported during their visits. (in collaboration with the caseworker)
- Promote mental health and encourage young people to seek support when needed to help them cope with the emotional challenges they may encounter in their transition to adulthood.

Developing life skills

Here are some important skills to develop:

- Teaching young people to manage their time and establish routines can help them become more organized and achieve their goals.
- Developing problem-solving skills can help them face the challenges of everyday life and make informed decisions.

By helping young people develop these skills, we give them the tools they need to succeed in their transition to adulthood.

What do Quebecers think about adoption?


Mixed bank foster families take in children they hope to adopt. However, between the wish of these families and adoption, there are several elements to take into account, including approval by a judge and the agreement of the biological parents.

COCON adoption (Comité de concertation adoption Québec) commissioned L'Observateur to carry out an exclusive survey to find out Quebecers' perceptions and understanding of adoption, including their level of knowledge and awareness of adoption in general, their opinion of the reality of the various members of the adoptive triad, and their level of support for the provision and support of adoption services.

Nearly 2 out of 3 Quebecers are concerned by adoption

A majority of Quebecers (64.2%) feel closely or remotely concerned by adoption, whether because they know someone in their circle, family or social network who has adopted or is being adopted.

Adopting seems more difficult

The survey also revealed that Quebecers think the challenges are greater for adoptive parents. For 68% of respondents, adopting would be more difficult than becoming a biological parent. Nearly 1 in 4 respondents, however, believe that the challenges are just as great in adoption situations as in biological parenthood.

Putting a child up for adoption: yes or no?

The Observer asked survey respondents how they felt about parents "giving away" their children for adoption.

Although the family model in which children are raised by their biological parents is the one recognized as being in the right order, for 87% of respondents, it is acceptable for a child to be made available for adoption when the biological parents demonstrate neglect, abuse or when the state judges their parenting skills to be inadequate.

For 64% of respondents, it's equally acceptable to give a child up for adoption in cases where the biological parents don't have the resources to support the child. On the other hand, 11% of respondents feel that, whatever the circumstances, it is preferable for a child to remain with his or her biological family.

A few observations

The 2020 survey revealed a number of findings:

- Adoption is perceived as complex. Perceptions of adoption are multifactorial and differ according to the point of view of the adoptee, the adopter, or the biological parents.
- 1 in 3 respondents would like to know more about the various adoption-related issues.
- Adoption is perceived as more difficult than becoming a biological parent.
- According to respondents, people involved in adoption should have access to more services and support.
- Adoption support organizations are not well known.

Hello to you all,

We're working hard to offer you training tailored to your needs. Here's some important news and information for you.

Online and face-to-face training courses

We've analyzed the popularity of training courses offered in recent months, enabling us to target an offering that's more in tune with your reality. From now on, we'll be giving priority to online training. It will still be possible for you to attend a face-to-face training session. To do so, you will need to contact your regional committee, in collaboration with the institution, to ensure that a minimum number of participants is registered.

Training, a source of good tips!

Alexandre Mercier, foster family in Mauricie/Centre-du-Québec has been welcoming 3 children since April 2021. To date, he has taken 10 online training courses, some of them twice. He tells us about Oppositional Defiant Disorder:

The training has given me the know-how to deal with children in a way that doesn't escalate and make the atmosphere negative for several hours, and that enables me to act more passively than reactively. Now, when the situation becomes more intense, we call it a "little red flag". It makes us realize the situation and change our approach. Thanks to this training, the family climate is more harmonious and moments of opposition are quickly contained."

English courses

Almost 90% of the training courses currently offered can be given in English, to make them more accessible to the English-speaking foster families we have in the regions served by the FFARIQ. In order to maintain this offer, we will soon be sending out a newsletter inviting you to register your interest in these training courses. Thank you for responding in large numbers.

YOUR CONTRACT as a foster family

Training courses are available to help you understand the guidelines surrounding your role, your requests, and your expectations. Here's one you'll find on VotreEspace in the Training section of the FF Know-How module.

Financial and administrative aspects - The outline of the specific agreement

In this course, you will learn about:

- The specific agreement is a contract signed by mutual consent between the resource and the institution. It cannot be modified or negotiated without your approval;
- The basis of the contractual relationship, which must be specified in the contract, such as the number of places, the age and gender of the children, the duration of the contract, etc.;
- This contract can be signed by one or two people.

Contract addenda and other forms

The only way to modify a contract during its validity period is to add an addendum. This can change the identity of the sponsor, the number of recognized places and the type of user.

This form is filled out at the foster family's request and is <u>not to be</u> used when a child leaves for a short stay in a rehabilitation center.

At any time, you can contact the FFARIQ before signing a form or contract with the institution. We'll guide you to what's best for you.

Classification

We haven't received any requests for classification reviews. Which is good news. However, we know from experience that there are sometimes things that fly under the radar because it seems only natural to do this for the children you care for. Don't hesitate to contact us to make sure that the services you offer to children correspond to the classification in which the institution has registered you. It's your right to be recognized and remunerated for the real responsibilities and burdens you have to assume.

Good collaboration with the DYP

Our collaboration with the DYP is going very well. The current social worker informs me when there is a problem with the foster families. She even gives my business card and contact details to new foster families so that they have access to information on the services that the FFARIQ offers to help them on a daily basis. This situation is quite exceptional and we really appreciate it.

I'd like to take this opportunity to remind you to contact us if you have any questions about transportation, harmonized visits between you and your biological parents, and so on.

Positions up for election: are you interested?

Hello dear foster families,

Increased consultations for classification

The reality of remote regions means that there are many changes in the social workers. This has an impact on support for foster families. Is this due to a lack of manpower? Perhaps.

As a result, new foster families don't feel supported by the institution. In fact, one new foster family told us that after 2 days, she would have given up because she felt so helpless.

This story reminds us how important it is for the FFARIQ and its regional committees to be there for our foster families. Call us, even for what may seem like a small matter. We're here for you, and we'll help you solve the problems you face every day.

Regional tour

Hello foster families, from Charlevoix to Portneuf to Quebec City!

Lower classification levels

There seems to be a downward trend in the level of assessment of children in our region at classification meetings. Often, this is due to a misinterpretation of the child's needs. Your regional committee is there to ensure that the child's needs are adequately recognized and that you are compensated fairly. Don't hesitate to discuss your concerns with us.

Relations with the institution

We've developed a good relationship with the institution regarding the training program. I'm able to accompany our foster families on these trainings, which allows me to see what they need. What's more, the training offered by the institution often focuses on the adult in foster care. By being there, I'm able to shed light on the realities of foster care for children.

There's also a big change in social workers, which means that services for foster families are slow, especially when it comes to requests to move a child when a situation requires it. For example, one family wanted to move a 24-year-old ASD child to an adult foster family. They were told it would take 1-2 years! It also takes a long time to respond to the need for support when problems arise with a child.

We also noticed differences in understanding and interpretation of the collective agreement from one social worker to another. For example, the DYP says that the CPR course is reimbursed by the FFARIQ, which is false. It is the institution that must reimburse this training.

Classification to be clarified

We've found that some foster families have been misclassified. These may seem like small details to you, but they're very important. If you have any doubts about the classifications of the children you foster, please give us a call.

Non-compliance with visiting regulations

Supervised visits with parents must be scheduled and you must be notified with reasonable notice, even if the visit is for an appointment with a health care professional. The same applies if the visit is cancelled. The provider has a duty to inform you. We've had a lot of complaints about this. We have asked the institution to remind its social workers of this procedure.

Activities

Stay tuned for the different activities we organize. Sometimes they are cafés or meals. Our next outing will be to the Cabane à sucre Bonaventure in Mirabel, on April 27 at 1:30 pm. You will receive the invitation shortly. Given the success of this activity in previous years, we have reserved 600 places. On this occasion, we'll also have the privilege of welcoming the interim provincial president, Mélanie Gagnon.

Don't doubt yourself, be confident!

Are we in the right place? Are we making the right choices? For whom or why are we making these choices? Are these questions you often ask yourself? We read situations shared by foster families on our regional Facebook page. Things like:

- "I have no choice but to accept this. The worker says I have to approve."
- "The social worker can't change the date of the visit."
- "The worker says I'm not in my place, because I don't know how to deal with the child. Yet I have 4 of them and I don't have any difficulties with the others."

There's no need for these comments or threats! I would like to remind you that the relationship between you and the social workers is not one of power. You are on equals. If this isn't your experience, give us a call. We'll help you figure out how to work with the institution in a respectful way that's good for both you and your child.

And I want to reassure you, there are no right or wrong choices. You make a large number of decisions every day. The ones you make in the moment, following your instincts, are often the best. Don't let yourself be put down by fear of reprisals.
